# Your challenge

### IF EVER THERE WAS A PROCESS RIPE FOR **AUTOMATION, IT IS SAMPLE MANAGEMENT**

Manual processes and paper trails are simply not up to the job. #### **DIGITAL SAMPLE MANAGEMENT APP**

The DSM App allows reps to quickly and easily determine sample stock levels and prepare digital requests, automatically checked against quota limits, by

- Selecting HCP from droplist or scanning Riziv number, via seamless integration with One Key
- Selecting or scanning product(s), including lot number(s)
- · Presenting digital request to HCP for Qualified Electronic Signature (QES) collected
  - » Immediately using Itsme
  - » Later using IQVIA's delayed signature solution


#### **KEY PROCESS FEATURES INCLUDE**

### Inbuilt digital sample quota check

· Automatically blocks requests if limits exceeded

#### **Qualified Electronic Signature**

• The most secure level of electronic signature and the ONLY one accepted by the FAGG



### **Delayed signature solution**

- Allows HCPs to sign at their convenience on **DOCCLE** platform using QES (Itsme or E-ID) via emailed link
- Enables reps to handle sample requests (eg, via email, website, phone) remotely without presence of HCP

# Optional automation of sample delivery via logistic 3rd party

 Optional API configured to fully automate delivery via logistic 3rd party in case of delayed signature, expensive sample or sample with special handling needs (eg, temperature)



#### **REAL-TIME DASHBOARD INSIGHTS**

Qlick dashboard gives managers real-time information on

- Number of sample requests filed by rep/region/ in total
- · Number of sample requests signed by rep/region/ in total
- Number of samples delivered by rep/region/in total (optional)
- List of HCPs to whom samples delivered by rep/ region/in total
- Signed request (pdf) including QES stamp for audit purposes
